Director of Public Safety Macon and Chief of Police Services Rudy provided general information on the Laguna Woods Elder Services Detail (ESD), which is a new Reserve program to help prevent and detect financial, physical, mental, and other forms of criminal elder abuse. The Sheriff's Department refers individuals to the ESD on an as needed basis. The ESD also assists with education and outreach services.

**B. Public Safety Volunteer and Community Education Program**

Director of Public Safety Macon provided a PowerPoint presentation on the proposed Public Safety Volunteer and Community Education Program, which would consolidate public safety and emergency response volunteer and educational opportunities in three tracks (Fire Safety; Care and Shelter; and, Disaster Clerical) with certain courses open to the general public, as well as current and prospective, eligible volunteers. It would also replace the Community Emergency Response Team Program.

The Public Safety Committee unanimously voted to approve the Public Safety Volunteer and Community Education Program concept.
