that would be timed to coincide with California Small Business Month in May 2018. The event would include incentives for residents to shop and dine locally. The event would help to raise awareness of local businesses and the value of shopping and dining locally, as well as promote a sense of community.

The consensus of the Board of Directors was to offer the Shop & Dine Passport event over the course of one week in May 2018, with no minimum purchase requirement, and to provide three locations for residents to drop-off their completed Shop & Dine Passports.
