DOG PARK ADVISORY GROUP MINUTES REGULAR MEETING October 9, 2018 3:00 P.M. Laguna Woods City Hall 24264 El Toro Road Laguna Woods, California 92637

I. CALL TO ORDER

Chair Cohen called the Regular Meeting of the Dog Park Advisory Group of the City of Laguna Woods to order at 3:02 p.m.

Chair Cohen led the pledge of allegiance.

IV. PUBLIC COMMENTS – None

V. ADVISORY GROUP BUSINESS

5.1 Advisory Group Minutes

Moved by Chair Cohen, seconded by Member Klampert, and carried unanimously on a 6-0 vote, to approve the Dog Park Advisory Group meeting minutes for the regular meeting on August 14, 2018.

5.2 "A Place for Paws" Dog Park Relocation Project

City Manager Macon made a presentation and responded to related questions on the "A Place for Paws" Dog Park Relocation Project, which included the status of construction, a review of the project timeline, information regarding changes that have been made to Phase 1 (addition of a gate for future connection to Phase 2; tree and water service modifications; addition of deodorizer and anti-microbial/anti-bacterial infill; and, addition of a hose quick coupler and water service modification), information regarding planned parking lot improvements, and the status of Phase 2.

Members of the Dog Park Advisory Group inquired about and discussed the following:

- The shade provided in the new dog park. Staff noted that additional trees will be planted, but that it will take time for those trees to mature.
- Project cost. Staff advised that the budget for the project is currently \$495,000, including Phase 1 design/construction and Phase 2 preliminary design costs.
- The maintenance schedule for the new dog park. Staff advised that the majority of regular maintenance activities will occur on Tuesdays between 7 a.m. and 1 p.m., while the dog park is closed. Some daily weekday maintenance will also occur, as well as additional, as-needed maintenance. Staff also provided information on the City's landscape maintenance services request for proposals process.
- Plans for securing the new dog park. Staff noted that Laguna Woods Village staff will continue to lock and unlock the dog park on a daily basis. The dog park will continue to have six-foot perimeter fences/walls.
- User interest in lighting to allow for expanded hours of operation. Staff noted that lighting may be considered as a part of future capital improvement projects.
- 5.3 Fundraising to Support the Dog Park

City Manager Macon noted that the Founders Wall fundraising program began on July 19, 2018 and the deadline to contribute is October 31, 2018. As of October 5, 2018, a total of \$4,450 had been received from 25 contributors (by contribution level: seven \$50 contributions, nine \$100 contributions, three \$150 contribution, one \$250 contribution, and five \$500 contributions).

Members of the Dog Park Advisory Group discussed the status of business fundraising and ways to generate increased interest in the Founders Wall fundraising program.

Chair Cohen noted his plans to appear with Mayor Moore on Laguna Woods Village's This Day television program to discuss the "A Place for Paws" Dog Park Relocation Project and promote the Founders Wall fundraising program.

City Manager Macon stated that the Laguna Woods Civic Support Fund Board of Directors is interested in the Dog Park Advisory Group's input on a potential commemorative tile fundraising program, particularly desired price point(s) and installation frequency.

Members of the Dog Park Advisory Group suggested and discussed the following, related to a potential commemorative tile fundraising program:

- Standardization in size and appearance. Members expressed a variety of opinions ranging from a preference for standardization in the interest of fabrication ease and uniformity of appearance, to a desire to allow significant levels of customization. A suggestion was made to consider dog paw shapes.
- Fabrication possibilities. Members suggested exploring a partnership with Laguna Woods Village clubs to use the kiln in Clubhouse 4 to finish tiles.
- Price points. Members were of general consensus between \$25 and \$100 per tile.

- Materials. Members suggested that metal or brick could be used in lieu of tiles.
- Promotion. Members suggested that the grand opening event for the new dog park could be an opportunity to solicit interest in fundraising programs.
- Installation frequency. Members were of general consensus that the fabrication and installation of tiles could be "batched" on a quarterly basis.

City Manager Macon reviewed the list of future Dog Park Advisory Group agenda items that was provided on the agenda.

DOG PARK ADVISORY GROUP MINUTES REGULAR MEETING December 11, 2018 3:00 P.M. Laguna Woods City Hall 24264 El Toro Road Laguna Woods, California 92637

I. CALL TO ORDER

Chair Cohen called the Regular Meeting of the Dog Park Advisory Group of the City of Laguna Woods to order at 3:05 p.m.

II. ROLL CALL

III. PLEDGE OF ALLEGIANCE

Chair Cohen led the pledge of allegiance.

IV. PUBLIC COMMENTS – None

V. ADVISORY GROUP BUSINESS

City Manager Macon noted that due to an inadvertent clerical error, while the Dog Park Advisory Group meeting minutes for the regular meeting on October 11, 2018 were included in the agenda packet, an agenda item to consider approving the same will be on the February 12, 2019 agenda.

5.1 "A Place for Paws" Dog Park Relocation Project

City Manager Macon made a presentation and responded to related questions on the "A Place for Paws" Dog Park Relocation Project, which included information regarding the delay in construction, the status of the resumption of construction, a review of the project timeline, and information regarding planned parking lot improvements.

Members of the Dog Park Advisory Group inquired about and discussed the following:

• Communication with residents and Founders Wall donors regarding the delay in construction. – Staff noted that the delay has not resulted in any change to the

improvements planned nor to the City's commitment to completing the project.

- The condition of the existing dog park as it relates to continued use during the delay in construction. Staff noted that the damaged portions of the perimeter fence will be repaired, that empty planter areas have been filled with mulch, and that decomposed granite surfaces will be refreshed. In response to a concern regarding empty dog waste bag dispensers, staff asked that City Hall be notified as soon as possible to allow for timely refills. Landscape maintenance contractors (Nieves Landscape through December 19, 2018; BrightView Landscape Services beginning on December 20, 2018) are scheduled to refill dog waste bag dispensers every weekday morning, as-needed. Staff can refill more frequently, if necessary.
- The potential for relocating large rocks from near the driveway entry to the parking lot. Staff advised that the suggestion will be considered.
- Traffic on Ridge Route Drive as it relates to use of the dog park. Staff noted that comments made by Dog Park Advisory Group members regarding the speed of traffic on Ridge Route Drive have been relayed to the Orange County's Sheriff's Department. Vehicle travel lanes are within the City of Laguna Hills' jurisdiction.

5.2 Fundraising to Support the Dog Park

City Manager Macon noted that the Founders Wall fundraising program began on July 19, 2018 and the deadline to contribute was October 31, 2018. A total of \$9,000 has been received from 54 contributors (by contribution level: seventeen \$50 contributions, fourteen \$100 contributions, ten \$150 contributions, five \$250 contributions, and eight \$500 contributions). Instead of unveiling the Founders Wall plaque after the relocated dog park opens, the plaque will now be installed prior to the grand opening, due to the delay in construction of the "A Place for Paws" Dog Park Relocation Project.

City Manager Macon stated that, at this point, staff anticipates that the Founders Wall plaque will be 18" x 20" cast bronze with a raised border, text, and graphics, as well as a high-durability clear coat. The plaque will be wall-mounted inside the relocated dog park.

Members of the Dog Park Advisory Group suggested that the deadline for Founders Wall contributions be extended through January 31, 2019, due to the delay in construction of the "A Place for Paws" Dog Park Relocation Project. City Manager Macon advised that the deadline would be extended and updated flyers would be made available shortly.

City Manager Macon noted that work on establishing a commemorative tile fundraising program will continue, but that staff's efforts at this point are focused on resolving the delay in construction of the "A Place for Paws" Dog Park Relocation Project.

City Manager Macon advised that while the Laguna Woods Civic Support Fund does not yet have the ability to accept contributions via credit card, development of that capability using an online application is in-process.

Members of the Dog Park Advisory Group discussed the possibility of selling a dog parkbranded item at the grand opening of the relocated dog park (e.g., leashes). 5.3 Dog Park Advisory Group Leadership

Moved by Vice Chair Sanchez, seconded by Member Hall, and carried unanimously on a 5-0 vote with Member Klampert absent, to appoint David Cohen to serve as chair effective immediately through December 2019.

Moved by Member Hall, seconded by Chair Cohen, and carried unanimously on a 5-0 vote with Member Klampert absent, to appoint Barbara Sanchez to serve as chair effective immediately through December 2019.

5.4 Future Advisory Group Agenda Items

City Manager Macon reviewed the list of future Dog Park Advisory Group agenda items that was provided on the agenda and responded to related questions. City Manager Macon noted that maintenance of the dog park will be a standing agenda item beginning with the meeting on February 12, 2019.

Members of the Dog Park Advisory Group commented on thefts from vehicles that have occurred in the dog park parking lot in the past and interest in public safety-related public outreach, as well as security cameras.

Member Hall raised the possibility of starting a newsletter for dog park users.

VI. ADJOURNMENT

The meeting was adjourned at 4:35 p.m. The next regular meeting will be at 3:00 p.m. on Tuesday, February 12, 2019 at Laguna Woods City Hall, 24264 El Toro Road, Laguna Woods, CA 92637.
