I. CALL TO ORDER

Mayor Horne called the Regular Meeting of the City Council of the City of Laguna Woods to order at 2:00 p.m.

IV. PRESENTATIONS AND CEREMONIAL MATTERS

4.1 Orange County Mosquito & Vector Control District Educational Video – Aedes Mosquitos

At the Orange County Mosquito & Vector Control District's request, City Manager Macon played a video regarding aedes mosquitos.

Councilmembers made comments.

4.2 Citizenship Day & Constitution Week – September 17-23, 2021

City Clerk Trippy read the proclamation.

Councilmembers made comments.

Moved by Mayor Pro Tem Moore, seconded by Councilmember Conners, and carried unanimously on a 5-0 vote, to approve the proclamation. This vote was conducted by roll call.

VI. CONSENT CALENDAR

Councilmember Hatch requested to pull Item 6.7 for separate discussion.

Moved by Councilmember Hatch, seconded by Mayor Pro Tem Moore, and carried unanimously on a 5-0 vote, to approve Consent Calendar items 6.1 - 6.6. This vote was conducted by roll call.

6.1 City Council Minutes

Approved the City Council meeting minutes for the regular meeting on July 21, 2021 and the special meeting on July 27, 2021.

6.2 City Treasurer's Report

Received and filed the City Treasurer's Report for the month of July 2021.

6.3 Warrant Register

Approved the warrant register dated August 18, 2021 in the amount of \$714,075.37.

6.4 City Attorney Services

Approved a legal representation letter amending the agreement with Rutan & Tucker, LLP for legal services as City Attorney and authorized the Mayor to execute the legal representation letter.

6.5 EnerGov and Incode Software

Approved an amendment of the agreement with Tyler Technologies, Inc. for Software as a Service ("SaaS") pertaining to the use of EnerGov and Incode software and authorized the Mayor to execute the amendment, subject to approval as to form by the City Attorney.

6.6 General Plan Housing Element Update Services

Increased the City Manager's authorization to execute agreements with LSA Associates, Inc. from an amount not to exceed \$95,000 to an amount not to exceed \$108,700 for General Plan Housing Element Update services, subject to approval as to form by the City Attorney.

6.7 Countywide Mass Notification System

Councilmember Hatch asked if the City's costs for police services would increase with the proposed agreement.

City Manager Macon responded that costs would not increase.

Moved by Councilmember Hatch, seconded by Mayor Pro Tem Moore, and carried unanimously on a 5-0 vote, to approve a memorandum of understanding between the County of Orange, the City, and other participants [which may include municipalities, public universities and water agencies responsible for protecting a resident population and maintaining a dedicated public safety answering point (PSAP) within the County of Orange] for use of countywide mass notification system and authorize the Mayor to execute the memorandum of understanding, subject to approval as to form by the City Attorney. This vote was conducted by roll call.

Mayor Pro Tem Moore asked about the protocol for removing items from the consent calendar.

City Attorney Patterson responded to Mayor Pro Tem Moore's question.

Councilmember Hatch made brief comments regarding consent calendar protocol.

7.1 Sign Program SP-1508 to allow for various signage at 24902 Moulton Parkway, Laguna Woods, CA 92637

City Manager Macon made a presentation.
