5.1 Investment Policy Review Committee Chair

5.3 Investment of Financial Assets Policy

Councilmember Horne introduced the item and made comments.

City Manager Macon noted that an initial draft of potential modifications to the investment policy was included in the agenda packet and reviewed those same draft modifications with the Committee. Most of the draft modifications are intended to address comments received on the California Municipal Treasurers Association scorecards that were also included in the agenda packet. The draft modifications are a work-in-progress. Staff expects to formally recommend modifications to the Committee in late-summer or fall, but sought preliminary input and feedback at this meeting.

Committee members discussed the item and staff answered related questions.

Committee members expressed support for the draft modifications, including an additional modification to revise the first paragraph of Section 2.2.07 as follows:

"As set forth in the City's Conflict of Interest Policy, and as otherwise required by the Political Reform Act and Fair Political Practices Commission, public officials who manage public investments are required to shall file economic interest disclosures."

Councilmember Horne requested that staff provide information at a future meeting regarding investment earnings over time, since the establishment of the Investment Policy Review Committee.

City Manager Macon responded that staff would provide the requested information.
