I acknowledge and understand that building and engineering permits that require allowances sought in any planning action cannot be approved by the City of Laguna Woods, and no development rights will be conferred, unless and until, all required planning actions are approved.

While commencing building and engineering plan review in advance of the approval of required planning actions may expedite project processing, I acknowledge and understand that there is substantial financial risk in doing so. I acknowledge, understand, and accept the risk that any of the following events may occur, which would result in increased costs: (1) any or all of the required planning actions are not approved, (2) the approval of any or all of the required planning actions results in conditions of approval

or similar requirements that result in the need to modify or redesign building or engineering plans that have been or are in the process of being prepared for plan review submittal, (3) the City of Laguna Woods identifies the need for additional planning actions required that result in the need to modify or redesign building or engineering plans that have been or are in the process of being prepared for plan review submittal, or (4) provisions of the Laguna Woods Municipal Code or applicable federal, state, or local laws change between the dates of submittal for building and engineering review and the dates of approval of required planning actions that result in the need to modify or redesign building and engineering plans that have been or are in the process of being prepared for plan review submittal (e.g., changes in the applicable California Building Standards Code). I acknowledge that I have had an opportunity to consult with legal counsel and accept the risk described in this affidavit. I further acknowledge and understand that the City of Laguna Woods neither encourages nor discourages concurrent plan review, but strongly encourages applicants to carefully consider the risk thereof and consult with legal counsel prior to making such a request.
